Reception Area Changes

We are keen on improving our patient services and have listened to your feedback about our reception area.

You said:

- the reception desk is not very private
- when reception staff are taking a call from a patient they are aware of other patients waiting at the desk for them to finish the call and often overhearing the conversation
- it is difficult for patients to tell staff about personal problems when a patient is standing in close proximity behind them

We did:

- We have now established a queuing system. Patients will be asked to wait by the sign that says 'PLEASE WAIT UNTIL YOU ARE CALLED'. This will give the reception staff the privacy they need to complete their telephone conversation with a patient before tending to the next patient.
- If your problem is very personal or you need to talk about something you cannot discuss at the reception desk, please hand one of the pink plastic cards available at each station to the receptionist. The receptionist will ask you to take a seat and then arrange for you to speak with someone in a more private space.

Reminder!

This is a gentle reminder that all specimens must be handed in to reception between 8am and 2.30pm every day to ensure they are in time for collection. Failure to meet the 2.30 pm deadline will result in your specimen being discarded and you will need to provide another specimen. Please ensure your specimen is correctly labelled and has the necessary paper work provided with it.

Say 'NO' to Lambeth Council's 12-2 pm Controlled Parking Zone Proposal

Lambeth Council is pushing a 2-hour Controlled Parking Zone (CPZ) in a **third** consultation, trying to overturn the overwhelming rejection by locals in 2024 (88.9%).

How will this affect our patients? This will mean that our patients will not be able to park on Croxted Road to access the surgery, the pharmacy or Tesco's between 12 pm and 2 pm every day.
